- 1. ORDERS.** All orders placed by Customer shall be subject to acceptance or rejection by LaCrosse Footwear, Inc. ("LFI") at LFI's corporate office in Portland, Oregon. No order shall be binding on LFI until the earlier of LFI's acceptance in writing or shipment and, in the case of acceptance by shipment, only as to the portion of the order shipped. No order may be canceled or modified by Customer after acceptance, unless LFI, in its sole discretion, elects to accept such cancellation or modification. All requests for cancellation or modification of an order must be submitted to LFI in writing at least 30 days prior to the requested start shipment date.
- 2. EXCLUSIVE TERMS AND CONDITIONS OF SALE.** Customer acknowledges and agrees that all sales of products by LFI shall be governed solely and exclusively by the terms and conditions of sale set forth herein, which terms and conditions shall supersede and prevail over all terms and conditions of customer's order. LFI's acceptance of a customer order is expressly conditioned on Customer's acceptance of the terms and conditions of sale set forth herein in their entirety without any additions, deletions, modifications or exceptions. Any terms or conditions submitted by Customer (in any purchase order, written instrument, or other communication) that are different from or in addition to the terms and conditions contained herein are hereby objected to and rejected by LFI, shall not be effective or binding on LFI, and shall not become a part of the contract of purchase and sale between Customer and LFI. LFI's silence or failure to respond to any different terms or conditions submitted by Customer shall not be deemed to be an acceptance or approval thereof.
- 3. PRICE.** LFI's prices vary depending on the type of product ordered. LFI reserves the right to change its prices, and any price quotation made to Customer, at any time without notice. All prices charged to Customer are exclusive of freight, shipping and insurance charges, and any sales, use, excise or similar taxes, all of which shall be paid by Customer.
- 4. DROP SHIP CHARGE AND SPECIAL HANDLING CHARGE.** A "Drop Ship" is defined as a direct to consumer order fulfilled directly from LFI to a location other than a certified LFI account. All Drop Ship orders to a single location will be charged \$10.00. LFI reserves the right, in its sole discretion, to limit the quantity of products shipped to any such location. If Customer requests any special handling services in connection with these orders, including but not limited to pre-ticketing, special labeling, custom insertions, additional fees may apply. There will be no charge for small orders, as defined as orders of less than 6 pairs delivered to a certified LFI account.
- 5. DELIVERY, RISK OF LOSS.** All products sold to Customer shall be sold F.O.B. place of shipment (the "F.O.B. Point"), at which time title to the products shall pass to Customer. Customer shall pay all freight, shipping and insurance charges; all sales, use, excise, or similar taxes; and any and all other costs or charges incurred after delivery of the products to the carrier at the F.O.B. Point. All risk of loss or damage from any cause whatsoever shall be borne by Customer after delivery of the products to the carrier at the F.O.B. Point.
- 6. CARRIERS.** LFI reserves the right, in making arrangements for shipment of products, to ship the products the most economical way possible under I.C.C. Regulations in effect on the date of shipment, and the right to ship products up to 30 days prior to the requested start ship date. Although LFI will, if possible, attempt to accommodate Customer's shipping requests (including requested carriers, shipment dates and delivery schedules), LFI shall, in its sole discretion, determine all carriers, shipping dates and delivery schedules. All carriers requested by Customer must serve the point of shipment on a direct basis with daily service during LFI's normal business hours, and must be available within 48 hours after LFI has completed packing the order.
- 7. PAYMENT.** All sales are cash in advance unless credit terms have been approved by LFI in writing in advance. If LFI elects to extend credit terms to Customer, payment shall be made by Customer in lawful money of the United States within 30 days of the date of LFI's invoice. LFI shall have the right to revoke any credit terms extended to Customer at any time and reinstate cash in advance on further sales to Customer. If Customer fails to pay any sum owing to LFI when due, or otherwise fails to perform any other obligation owing to LFI, LFI shall have the right, at its option and in its sole discretion, in addition to any and all other rights or remedies, to cancel any pending orders, or to stop shipment in transit, or defer shipment, of any pending orders until Customer has paid all sums owing in full and otherwise fully complied with all obligations owing to LFI. Customer shall pay a late payment charge on any invoice not paid in full within 30 days of the date thereof equal to 1.5% per month of the unpaid balance, or if said 1.5% is deemed to be unenforceable under applicable law, the highest late payment charge permissible under applicable law.
- 8. DUTY TO INSPECT UPON DELIVERY.** Customer shall inspect all products immediately upon delivery and shall give written notice to LFI within ten (10) days of the date of delivery as to any discrepancies between LFI's invoice and the quantity of products received, or any claim that the products are damaged or otherwise non-conforming to the terms and conditions of sale set forth herein. If Customer fails to give such notice within ten (10) days of date of delivery, the products shall be deemed to be satisfactory, Customer shall be deemed to have accepted the products, and Customer shall have no right to thereafter assert any claim against LFI with respect to shortages or damaged or non-conforming products. Customer expressly waives any right Customer may have to revoke acceptance after the expiration of said 10 day period. If any credit memo is issued by LFI to Customer, including any credit memo for invoice adjustments or returns, such credit memo must be used, and applied to new invoices issued to Customer in connection with the purchase of other products, within six months of the date the credit memo was originally issued by LFI.
- 9. LIMITED WARRANTY.** If LFI provides an express limited warranty with respect to a product, the terms of such limited warranty, and all exclusions, disclaimers, and limitations that apply thereto, shall be set forth in writing by LFI and delivered to the Customer with the product. LFI reserves the right, in its sole discretion, to change any limited warranty, and to change any exclusions, disclaimers, and limitations relating to any limited warranty, at any time and from time to time.

DISCLAIMER OF WARRANTIES.** EXCEPT FOR ANY EXPRESS LIMITED WARRANTY SET FORTH BY LFI IN WRITING AND DELIVERED TO THE CUSTOMER WITH THE PRODUCT TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, LFI DISCLAIMS ALL WARRANTIES, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, OR ANY WARRANTIES ARISING FROM COURSE OF DEALING OR USAGE OF TRADE.

11. **PRODUCT DESCRIPTIONS.** Customer acknowledges that any and all descriptions of the products, whether in writing or made verbally by LFI or any employee, agent or other representative of LFI, specifically including without limitation any and all descriptions and features of the products set forth in LFI's catalogs and price lists, are for the sole purpose of identifying the products and shall not be construed as express warranties by LFI. Customer further acknowledges that no employee, agent or other representative of LFI is authorized to make any warranty, or assume any liability, on behalf of LFI, and that any statements or suggestions by LFI, or any employee, agent or other representative of LFI, regarding the use, application or suitability of the products shall not be construed as express warranties by LFI.
12. **LIMITATION OF LIABILITY.** To the maximum extent permitted by applicable law, LFI's sole liability to customer or any other third-party for a claim of any kind arising as a result of, or related to, the sale of any product to customer, shall be expressly limited to, and shall in no event exceed, the purchase price paid by customer for the product. Under no circumstances shall LFI be liable or responsible to customer or any other third-party for any indirect, special, incidental, or consequential damages of any kind (including lost profits), or any exemplary or punitive damages, arising from, or in any way related to, the manufacture, sale, use, inability to use, or performance of any products purchased from LFI. These limitations and exclusions shall apply notwithstanding any failure of any essential purpose of any limited remedy and regardless of whether damages are sought based on breach of contract, breach of warranty, negligence, strict liability in tort or any other legal or equitable theory. Some states and other jurisdictions do not allow the exclusion or limitation of indirect, special, incidental or consequential damages, so the foregoing limitations or exclusions may not apply to customer. No action, regardless of form, arising out of the sale of products to customer maybe brought by customer against LFI more than one year after the date of delivery of the products to customer.
13. **RETURNS.** No products may be returned by Customer unless (i) LFI has, in its sole discretion, agreed in writing to accept such returns by issuing an RMA, and (ii) customer has complied with all conditions imposed by LFI in agreeing to accept such returns, specifically including without limitation paying all shipping, freight and insurance charges incurred in returning the products, and paying a re-stocking fee to LFI equal to 15% of the purchase price of the products returned. Customer shall submit all requests for acceptance of returns to LFI in writing within 30 days of the date the products were delivered to Customer. Notwithstanding the foregoing, in the event Customer desires to return an alleged defective product in connection with the exercise of any limited warranty rights, Customer shall abide by, and comply with, the instructions set forth by LFI in the written limited warranty that LFI provides to the Customer in connection with the sale of the product. LFI will accept no returns of merchandise from dealer or consumer purchased under a close out agreement. If product is returned to LFI without an RMA, LFI, at its sole discretion, may return the product to the Customer at the Customer's expense.
14. **CHANGES TO PRODUCTS.** LFI may at any time, in its sole discretion, discontinue any product, or change the design, specifications, materials or construction of any product without notice to Customer and without liability or obligation to Customer.
15. **FORCE MAJEURE.** LFI shall have no obligation or liability whatsoever arising out of or in connection with any delay or failure to perform any of its covenants or obligations under this Agreement or any purchase order placed hereunder, or any loss or damage incurred by Customer as a result thereof, if such delay or failure is caused, in whole or in part, either directly or indirectly, by act of God, fire, war, riot, civil insurrection, accident, embargo, transportation delays, governmental priority, shortage or failure of supply of materials or inability to obtain materials at current prices, strikes or other labor trouble, changes in production schedules, discontinuance of any product, decree or order of any court or government, acts of domestic and/or international terrorism, or any other occurrence, act, cause or thing beyond the control of LFI, whether related or unrelated or similar or dissimilar to any of the foregoing, any of which shall, without liability, excuse LFI from performance.
16. **GENERAL PROVISIONS.**
 - 16.1 The terms and conditions of sale set forth herein (as modified and supplemented by any written instrument hereafter signed by a duly authorized officer of LFI) constitute the entire final and complete agreement and understanding of the parties with respect to LFI's sale of products to Customer, and shall supersede and prevail over all terms and condition set forth in Customer's order. None of the terms and conditions contained herein may be added to, modified, superseded or otherwise amended, unless such addition, modification or amendment is set forth in writing and signed by a duly authorized officer of LFI. None of the terms and conditions contained herein shall be qualified or interpreted by any trade usage or prior course of dealing not expressly made a part hereof.
 - 16.2 All rights, remedies and liabilities herein given to or imposed upon the parties shall extend to, inure to the benefit of and bind, as the circumstances may require, the parties and their respective heirs, personal representatives, successors and assigns. No waiver of any provision of this Agreement shall be deemed, or shall constitute, a waiver of any other provision, whether or not similar, nor shall any waiver constitute a continuing waiver. No waiver shall be binding unless executed in writing by the party making the waiver.
 - 16.3 If any portion of the terms and conditions contained herein, or their application, is construed to be invalid, illegal or unenforceable, then the other portions of such terms and conditions shall not be affected thereby and shall be given full force and effect without regard to the invalid or unenforceable portions.
 - 16.4 The parties' agreement with respect to LFI's sale of products to Customer, as set forth in the terms and conditions contained herein, shall be governed by, and construed and interpreted in accordance with, the laws of the State of Oregon (excluding the choice of law rules thereof).
 - 16.5 All disputes, differences or questions arising out of or relating to LFI's sale of products to Customer, as set forth in the terms and conditions contained herein, or the validity, interpretation, breach or termination thereof, shall be resolved by binding arbitration in accordance with the following provisions: (a) the arbitration shall be administered by, and conducted in accordance with, the rules of the Arbitration Service of Portland, Inc.; (b) judgment on the award rendered by the arbitrator may be entered in any court having jurisdiction over the subject matter of the controversy, and the resolution of the disputed matter as determined by the arbitrator shall be final and binding on the parties; (c) any arbitration shall be instituted and conducted in Portland, Oregon and Customer irrevocably waives any objection to the laying of venue of the arbitration in Portland, Oregon, or any claim that such arbitration has been brought in an inconvenient forum; and (d) the arbitrator shall have authority to issue preliminary and other equitable relief.

RETURNS AND WARRANTY

LIMITED WARRANTY. Danner warrants to original end-user customer its footwear products will be free from defects in materials and workmanship and, with respect to waterproof footwear products, free from leakage in normal use, for one year from the date of original purchase.

EXCLUSIONS. Limited warranty does not cover, and Danner shall have no obligation or liability with respect to, any damage or problems resulting from:

- Normal wear and tear. Cuts, abrasions or damage resulting from anything other than normal and ordinary use of the product.
- Damage caused by chemical or other foreign body contamination and alterations, modifications or repair work performed by anyone other than Danner.
- Failure to adequately maintain product, including proper cleaning and leather conditioning.
- Use of any safety-toe (NMT, Alloy or Steel) or metatarsal-guard boot after boot has sustained an initial impact in excess of specified ASTM rating. Safety toe or metatarsal guard may be shattered or otherwise damaged as a result of such impact. Boots should not thereafter be used in any environment that requires a safety toe or metatarsal-guard.
- Improper or inadequate fit (once footwear product has been worn/used).

EXCLUSIVE REMEDY. Danner shall have no liability or responsibility under this limited warranty beyond repair or replacement of defective product, in Danner's sole discretion, and repair or replacement of defective product shall be customer's sole and exclusive remedy for breach of this limited warranty.

DISCLAIMER OF UNSTATED WARRANTIES. EXCEPT FOR THIS LIMITED WARRANTY, TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, DANNER DISCLAIMS ALL OTHER WARRANTIES, WHETHER ORAL OR WRITTEN, EXPRESS OR IMPLIED, STATUTORY OR OTHERWISE, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

EXERCISE OF LIMITED WARRANTY RIGHTS. To exercise his or her rights under this limited warranty, customer must return the defective product to the place of purchase within the applicable warranty period, together with a dated sales receipt as proof of purchase.

Retailers are free to sell Danner products at any price they choose, but should be aware that the consequence of advertising those products below LFI's Minimum Advertised Price (MAP) include discontinuation of affected styles and, ultimately, loss of Danner account status. The following activities will not be construed to be in violation of LFI's Minimum Advertised Price (MAP) Policy:

- Dealer may advertise below MAP during the pre-approved and designated timeframes communicated by LFI.
- Year-round store-wide loyalty programs.
- Sale of closeout and discontinued styles.
- Sales by Government agencies or departments for provision or resale to employees of those departments in connection with their official duties.
- Quantity discounts for bids issued by Federal, State, local or other government agencies.

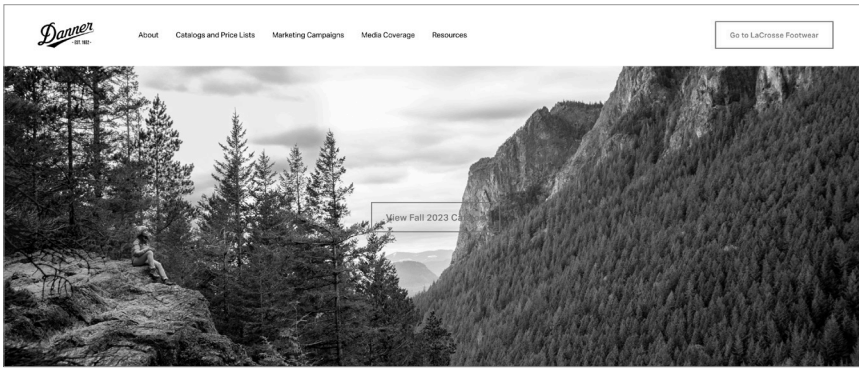

2. A dealer or distributor site should be easily identifiable as a site belonging to the specific dealer or distributor and cannot be represented as part of LaCrosse Footwear, Inc. Use of a domain name should not contain reference to any specific LaCrosse Footwear, Inc. brand.
3. All online product imagery, logos, affiliate logos and policy documents used must be provided by or approved by LaCrosse Footwear, Inc. Use of logos and imagery to follow documented graphic standards provided by LaCrosse Footwear, Inc. and be pre-approved by LaCrosse Footwear, Inc. before going live online.
4. Information and HTML or other source code on any LaCrosse Footwear, Inc. site may not be duplicated or directly copied.
5. Use of affiliate logos and reference must comply with the specific affiliates copyright policies.
6. Links to any LaCrosse Footwear, Inc. site will be allowed, however, notification to the LaCrosse Footwear, Inc. Ecommerce Webmaster must be provided in advance of the use of the link.
7. MAP policies must be strictly complied with. Action taken by LaCrosse Footwear, Inc. will be taken unilaterally and could include terminating both the online account as well as the brick-and-mortar operation. *See LFI MAP Policy for details.
8. LaCrosse Footwear, Inc. reserves the right to terminate an account's online business at our discretion.
9. An online retailer must take possession of a core assortment of inventory. LaCrosse Footwear, Inc. will not fulfill drop-ship orders that make up more than 35% of the retailer's business.

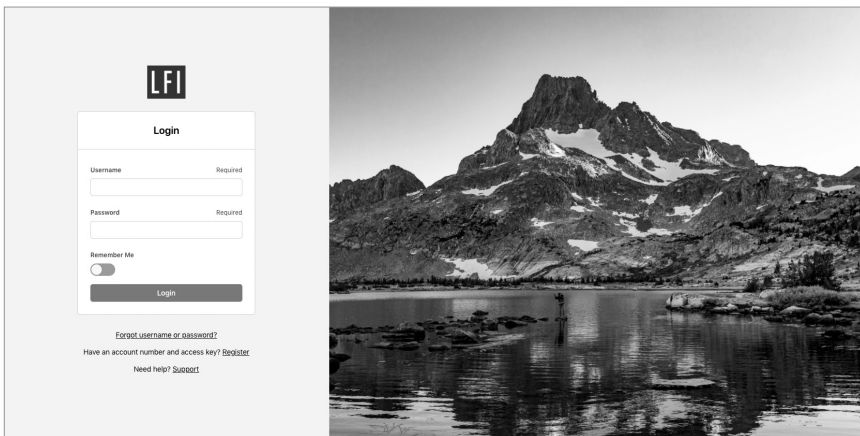
